

Black Hills Area Ghost Towns by Wallace "Wally" Slattery

DEADWOOD-LEAD and vicinity

You will probably be amazed to learn that 20 towns made up the present Deadwood-Lead urban area. Miners would set up their own hopeful town site, only to have it absorbed into the present towns. The towns (courtesy of Bill Swanson) were:

Montana City, Elizabethtown, Fountain City, Chinatown, North Deadwood, South Deadwood, Whoop up, City Creek, Cleveland, Ingleside, Pluma, Gold Run, Blacktail, Gayville, Golden Gate, Anchor City, Oro City, Pimlico, Central City, and Lead. Can you imagine the mailman's plight, trying to keep everyone's addresses straight? Let's discuss some of the more interesting little towns, not including Deadwood and Lead:

Montana City was on Whitewood Creek near the mouth of Split Tail Gulch, above the huge slag pile on the north end of Deadwood. It was big enough to merit a 4th of July oration by Judge Maguire.

Chinatown was the largest town of its ilk in the country back in the late 19th

century. The Chinese had their own fire company, their own masons, and many shops and clubs. According to reports, you could smell the incense/opium a block away.

Pluma, at the confluence of Gold Run and Whitewood Creeks, has the electrical generating plant and a number of stores. It also used to have a large gold smelting industry, and was often mentioned in the newspapers of the time.

Central City is between Lead and Deadwood, on Route 85. It has a number of small businesses and the Broken Boot Mine. If you are looking for a convenient place to go gold panning successfully, park just up the hill on Rt. 85 from the Broken Boot, and pan in the creek - but look out for mountain lions!

Wouldn't you have just loved to visit the area in the early days??


