Ghost Stories

REYNOLDS RANCH

I said that the last story was my last ghost town story. Then my old friend Dennis Olson, who grew up around Hot Springs and Rapid City, reminded me of Reynolds Ranch. This old ranch, south of Deerfield, was established in the very early days as a stage stop. The story says that when Indian raiding parties would appear, one of the family sons would climb the top of nearby Flag Mountain and with a flag or bugle make a pretense of summoning the U.S. Cavalry, thus driving off the Indians. Wonder if something like that would work in Afghanistan? Anyway, the raiders would then pull out in passing gear! Here's an old Slattery family story I know you will enjoy. My great Aunt Cora eloped with Charles Davis in December 1895 from the old Slattery ranch west of Chadron. Here is the actual newspaper account of this adventure: From the Columbus [Nebraska] journal, January 8, 1896

Married: Davis-Slattery - The following, to the Omaha World Herald, of Dec. 30, will be read with interest by many of our readers who knew the lady in question as a young girl in this city years ago. "Friends of Miss Cora Slattery, a dashing

young Chadron school teacher of some 23 summers, were much surprised to learn this morning that she had eloped in company with a Deadwood miner, Charles Davis, who has borne a rather shady reputation hereabouts. Davis came to town Saturday night in a lumber wagon, met Miss Slattery, and together they repaired to the residence of the county judge, who married them. They then proceeded to the home of Mrs. Slattery and secured the bride's trunk, bicycle[!], etc., and drove to Dakota Junction, where they boarded the train for Deadwood. Miss Slattery was a highly respected young lady, a graduate of the high school and Chadron Academy. Mrs. Slattery, the girl's mother, is heartbroken over the affair. None of the family were apprised of the intention of the couple but her brother Ernest [my grandfather] who received a short note the following morning, saying that that she intended to get married." It is to be hoped there is some mistake about the young man and that he is better than he is painted.

OOOEEE! Can you imagine a paper writing up a marriage in that fashion today? You would have a lawsuit worthy of a story on Fox News! Actually, I don't think Charlie Davis was that awful - he was the first elected sheriff of Harding County, where he served two terms.


